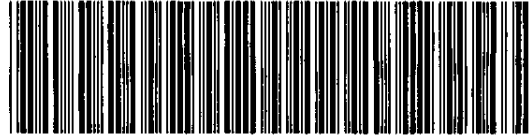

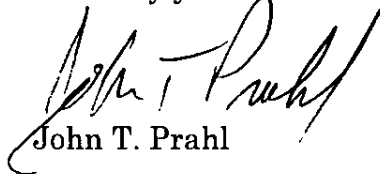

Statement of Authority of Mountain Investment of South Florida, LLC
