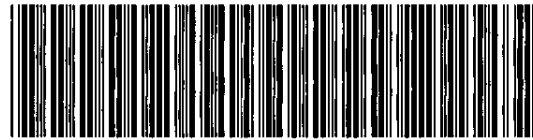

## Articles of Organization

of

### PRACHT YOUNG FARM, LLC

(A Florida Limited Liability Company)

The undersigned organizer hereby adopts these Articles of Organization for the purpose of forming a Limited Liability Company under The Florida Limited Liability Company Act, Chapter 608 of the Florida Statutes (the "Act").

1. **NAME.** The name of this limited liability company (the "Company") is **PRACHT YOUNG FARM, LLC.**

2. **DURATION.** The period of duration of the Company shall be perpetual.

3. **PURPOSE.** The primary purpose of the Company is to serve as General Partner of The Pracht Family Limited Partnership. The Company shall be authorized engage in any lawful act or activity which may be carried on by a limited liability company under the Act.

4. **MAILING ADDRESS AND STREET ADDRESS OF PRINCIPAL OFFICE.** The mailing address and street address of the principal office of the Company is: 1314 East Venice Avenue, Suite E, Venice, Florida 34285.

8. **LIMITED LIABILITY.** No Member or Manager or agent of the Company shall be liable under a judgment or decree, or order of a court, or in any other manner for any debt, obligation, or liability of the Company.

No Member shall be entitled to receive a return of capital or other distribution upon withdrawal from this limited liability company or otherwise, except as otherwise provided in the Operating Agreement of the Company.
