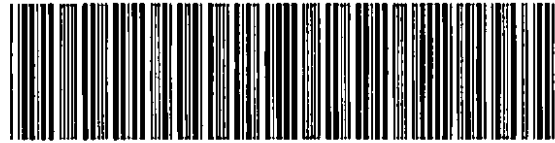

FINAL DEFAULT JUDGMENT

This matter, having come before the Court on the motion for default judgment of the above named Plaintiffs Gemini Billing Services, LLC ("**Gemini**"), Bethany McCune and Kevin T. McCune (collectively "**Plaintiffs**") against Courtney Mizner Cox (the "**Defendant**"), and the Court, being fully advised in the premises, finds as follows:


1. Jurisdiction and venue are proper in this Court.
2. The Defendant's 50% ownership of Gemini is forfeited, and Bethany McCune is the 100% owner of Gemini.
3. This Final Default Judgment is well taken and should be entered.

**IT IS THEREFORE ORDERED AND ADJUDGED** that final judgment is entered in favor of Plaintiffs Gemini and Bethany McCune against Defendant for \$500,593.90, which includes all damages and attorneys' fees and expenses. Interest shall accrue at 8% per annum. Bethany McCune is hereby the 100% owner of Gemini.

**IT IS THEREFORE ORDERED AND ADJUDGED** that final judgment is entered in favor of Plaintiff Kevin McCune against Defendant for \$6,185.51, which includes all damages and expenses. Interest shall accrue at 8% per annum.

**IT IS THEREFORE ORDERED AND ADJUDGED** that Defendant is required to pay  
all costs of court.
