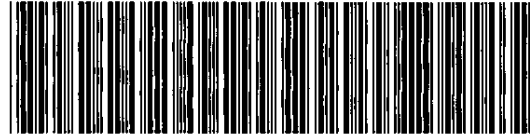

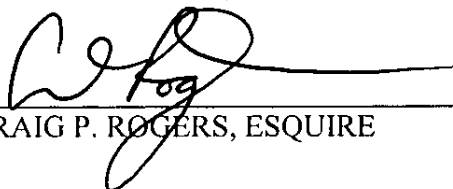

**ARTICLES OF ORGANIZATION
OF
KD001, L.L.C.**

The undersigned, for the purposes of forming a limited liability company under the Florida Limited Liability Company Act, hereby make, acknowledge and file the following Articles of Organization:

ARTICLE I - NAME

The name of the Limited Liability Company shall be KD001, LLC, (Company).

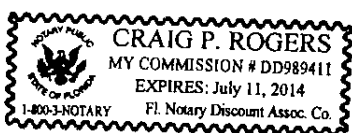

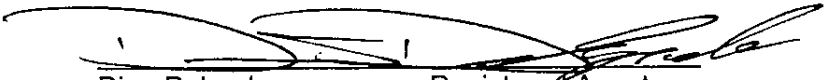
