The undersigned, desiring to form a limited liability company under and pursuant to Section 608 of the Florida Statutes, entitled the Florida Limited Liability Company Act, does hereby adopt the following Articles of Organization for such company.

**ARTICLE I
NAME**

The name of the limited liability company, hereinafter referred to in these Articles as "Company," is **JUDEEN MAE, LLC**.

**ARTICLE II
ADDRESS**

The Company's street address of its principal place of business in Florida is 2525 Bayou Blvd., Pensacola, Florida 32503 and its mailing address is the same, but it shall have the power and authority to establish branch offices at such place or places as may be designated by the Member or Members.

AMENDMENT TO ARTICLES**




