**ARTICLES OF ORGANIZATION

The existence of the Company shall begin at the time of filing of these Articles of Organization with the office of the Florida Secretary of State and shall be perpetual thereafter.


**ARTICLE III - PRINCIPAL ADDRESS AND MAILING ADDRESS**


