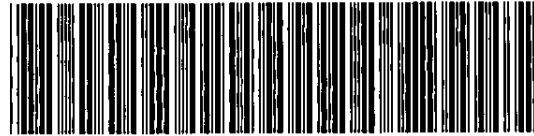

ARTICLE VIII - AMENDMENT

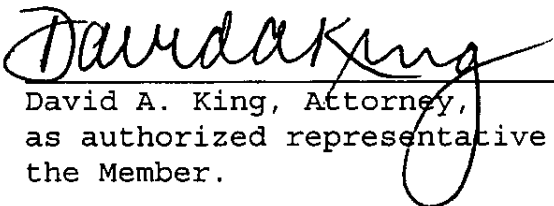

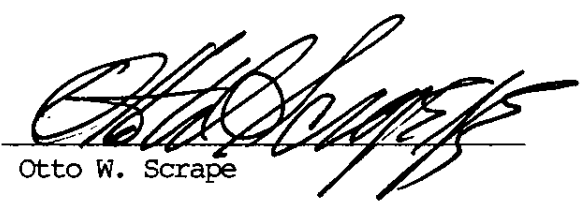
