

1. Name. The name of this limited liability company is McQuaid Marketing & Promotions, LLC, a Florida limited liability company (the "Company").
2. Duration. The Company shall have perpetual existence commencing on the filing of the Articles of Organization with the State of Florida and continues even though a membership of a member is terminated.
3. Purpose. The Company is organized for the purpose to plan and promote properties, events, businesses and activities of all nature and to engage in any business permitted under Florida law and to engage in such other lawful activities as are reasonably necessary, convenient or incidental to those purposes.


8. Member of the Company. The name and address of the only initial member is:

10. Certificated Interests. The member's interests in the Company may but need not be evidenced by certificates.


