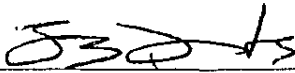

The undersigned person forms a Florida limited liability company pursuant to the Florida Limited Liability Company Act, as follows:

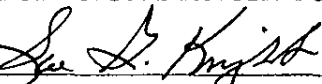
