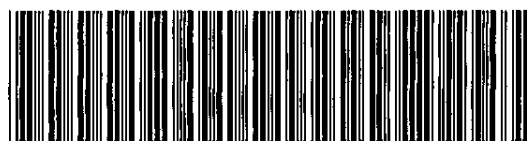

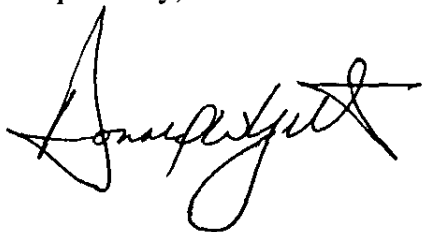

ARTICLES OF ORGANIZATION

OF

IRON TRIANGLE, LLC

ARTICLE I - NAME

THE NAME OF THIS Limited Liability Company shall be IRON TRIANGLE, LLC,

ARTICLE II - ADDRESS

THE MAILING ADDRESS and street address of the principal office of the Limited Liability Company shall be 3308 50th Ave E, Bradenton, Florida 34203.

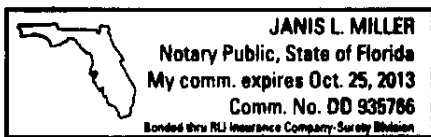

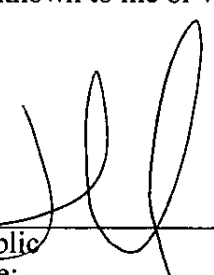
