ARTICLES OF ORGANIZATION OF TJ JACK 6, LLC

SEUNLTARY OF STATE. TALLAHASSEE, FLORIDA

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I - Name
