ARTICLES OF ORGANIZATION OF

Fonseca 20 Holdings LLC

The undersigned, being a duly authorized representative of the Member(s), desiring to form a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, does hereby adopt the following Articles of Organization:

ARTICLE I NAME

The name of the limited liability company is Fonseca 20 Holdings LLC (the "Company").

ARTICLE II ADDRESS

The Manager(s) shall serve in such capacity until their successor(s) are duly elected and qualified.

The purpose for which the Company is being formed is to engage in any activity or business permitted under the laws of the United States and the State of Florida including activities within the United States and abroad.


ARTICLE VIII
