## ARTICLES OF ORGANIZATION OF RUMORS DINER, LLC

2112 OCT -2 ACT

The undersigned, for the purpose of forming actimized liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

#### ARTICLE I -- NAME

The name of the limited liability company shall be RUMORS DINER, LLC ("company").

#### ARTICLE II -- ADDRESS

#### ARTICLE JII -- DURATION
