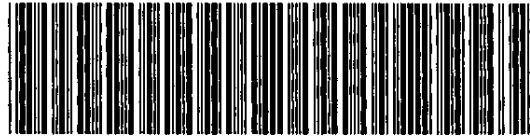

Attached is the revised documents regarding the closing of 2 LLCs. The 1<sup>st</sup> one, PIZZASLINGERS, LLC was started by Chas Warner who had disappeared after being thrown in jail. He has been uncooperative in providing necessary paperwork so we opened the 2<sup>nd</sup> LLC to pick up the pieces and attempt to move forward with the company. It proved to be past the point of no return and we were unable to turn the ship around. The store closed on 11/25/2012.

Both LLCs should be treated as one and the same entity. The dates of operation can be combined to reflect our business from start (1/31/2012 – 11/25/2012).

Since Chas has been non-responsive, we were not able to obtain his signature for the PIZZASLINGERS LLC that he was a member of. The remaining members have all signed. We are concerned that if left open, Chas may attempt to secure credit or accounts with the name.


