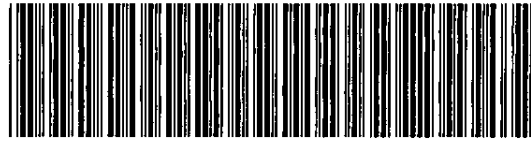

ARTICLE I NAME

The name of the limited liability company shall be RIDER REMODELING & HOME IMPROVEMENTS, LLC referred to these in these Articles of Organization as the "Company".


