**AMENDED AND RESTATED ARTICLES OF ORGANIZATION
OF

SPF PROPERTY MGT., LLC, a Florida limited liability company (the "Company"),
does hereby certify as follows:

1. The original Articles of Organization of the Company were filed with the Florida Department of State on October 4, 2012 (Florida Division of Corporations document number L12000126876).

2. Under the provisions of the Florida Limited Liability Company Act, Chapter 608, *Florida Statutes*, and pursuant to Section 608.411, *Florida Statutes*, the Company's Articles of Organization are hereby amended and restated in their entirety as follows:

The undersigned, acting as an authorized representative of the members of the above captioned Limited Liability Company, under the provisions of the Florida Limited Liability Company Act, Chapter 608, *Florida Statutes*, adopts the following Amended and Restated Articles of Organization:

ARTICLE I
NAME AND ADDRESS

The name of this limited liability company is SPF PROPERTY MGT., LLC (the "Company"), and its principal office and mailing address is 14620 N. Nebraska Avenue, Building B, Tampa, Florida 33613.

ARTICLE II
EFFECTIVE DATE

The Company commenced its existence as of October 1, 2012, the effective date set forth in the Company's original Articles of Organization.
