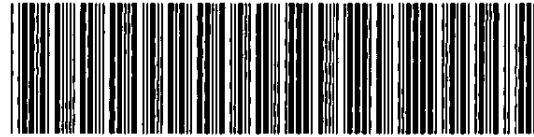

4. Place of Principal Office. The mailing and street address of the Company's principal office is 2405 Brandywine Court, Valrico, Florida 33594.


