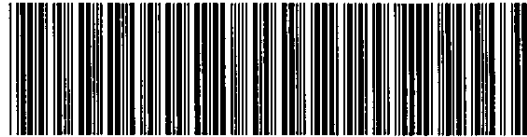

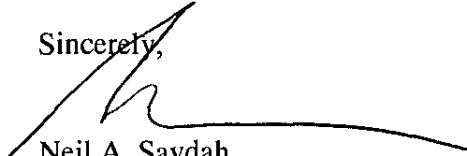

Operating Agreement

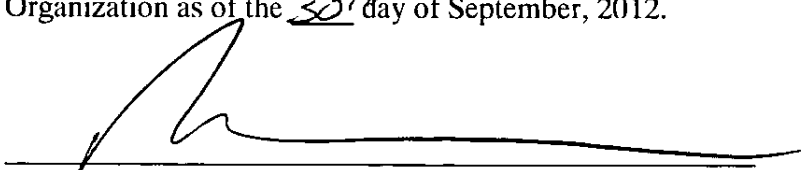
