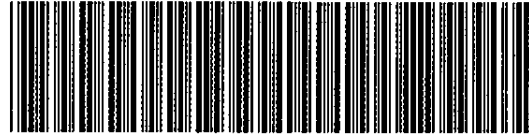

The undersigned, desiring to form a limited liability company under and pursuant to Florida Statute 608 entitled the Florida Limited Liability Company Act, do hereby adopt the following Articles of Organization for such company:

1. Name. The name of this company shall be **BLACK FAMILY PROPERTY, LLC**
2. Duration/Continuation. The period of this company's duration shall be perpetual unless terminated by the unanimous written agreement of all members.
3. Address. The mailing and street address of the company is **376 SW Broderick Drive, Lake City, FL 32025**.

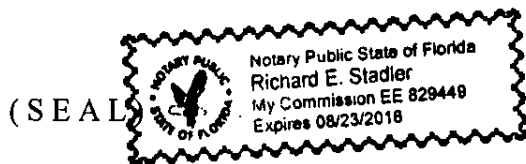

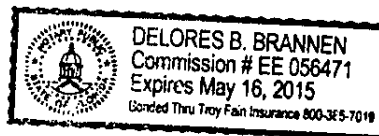
