**AMENDED AND RESTATED  
ARTICLES OF ORGANIZATION  
OF  
VEDDER HOLSTERS LLC**

The Articles of Organization of Vedder Holsters LLC, a Florida limited liability company (the "Company"), were filed with the Florida Department of State on October 8, 2012 under Document Number L12000127955. Pursuant to Section 605.0202 of the Florida Revised Limited Liability Company Act (the "Act"), the Articles of Organization are hereby amended and restated in their entirety to read as follows:

**I. NAME**

The name of the Company is Vedder Holsters LLC.

**II. PRINCIPAL OFFICE**

**III. REGISTERED OFFICE AND AGENT**
