**ARTICLES OF ORGANIZATION
OF
JDG VENTURES OF FLORIDA, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, *Florida Statutes* Chapter 608 (the "Act"), hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be JDG VENTURES OF FLORIDA, LLC (the "Company").

ARTICLE II - ADDRESS

ARTICLE III - DURATION

ARTICLE IV - REGISTERED OFFICE AND AGENT

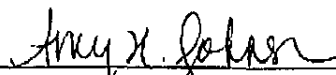
