AMENDMENT TO THE ARTICLES
OF ORGANIZATION OF
JG OPERATIONS OF FLORIDA, LLC

The undersigned, for the purpose of amending the Articles of Organization of JG OPERATIONS OF FLORIDA, LLC pursuant to §605 of the Florida Revised Limited Liability Company Act, F.S., hereby makes, acknowledges, and files this Amendment to the Articles of Organization of JG OPERATIONS OF FLORIDA, LLC. The original Articles of Organization were filed with the Florida Department of State on October 8, 2012. The Amendment is set forth as follows:

1. The name of this Company is JG OPERATIONS OF FLORIDA, LLC.
2. The Articles of Organization of JG OPERATIONS OF FLORIDA, LLC have been amended by deleting Article IV in its entirety and by substituting in lieu thereof the following Article:

"Article IV – REGISTERED AGENT AND OFFICE

The name and street address of the registered agent of the Company in the State of Florida is Brant, Reiter, McCormick & Johnson, P.A., 50 North Laura Street, Suite 2750, Jacksonville, Florida 32202.

3. The Articles of Organization of JG OPERATIONS OF FLORIDA, LLC have been further amended by deleting Article V in its entirety and by substituting in lieu thereof the following Article:

"Article V - MANAGEMENT

The Company shall be managed by a Manager. The Manager as of the date of this Amendment is JG Operations Holdings, LLC, which shall manage the Company in accordance with the terms of the Operating Agreement of the Company, if any, and applicable law.

4. The referred to Amendments were adopted by the Company effective as of April 1, 2016, by all of the Members of the Company.
5. Upon the filing of these Articles of Amendment by the Department of State, the above referred to Amendment shall become effective and the Articles of Organization of JG OPERATIONS OF FLORIDA, LLC shall be deemed to be amended accordingly.
