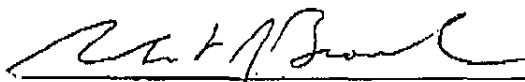
The Articles of Organization were filed with the Florida Secretary of State on October 9, 2012.

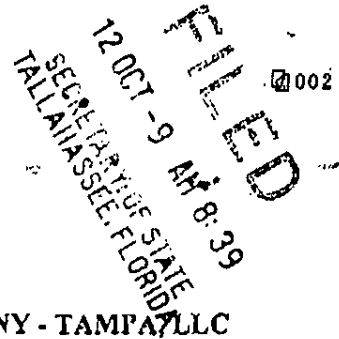
