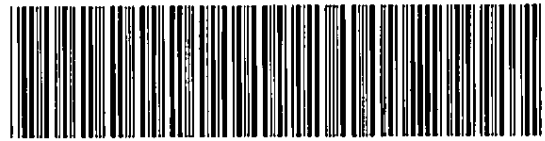

LIMITED POWER OF ATTORNEY**
