ARTICLES OF ORGANIZATION OF MATALONA THOROUGHBREDS LLC

FILED

The undersigned subscriber to these Articles of organization ("Articles"), being a natural personal to competent to contract, hereby forms a Limited Liability Company under the laws of the State of Florida.

ARTICLE I. – NAME. Matalona Thoroughbreds LLC is the name of this Organization (hereinafter ASSEE, FLORIDA referred to as the "Company").

ARTICLE II. - PRINCIPAL OFFICE. The principal office of the Company is 4622 West Lamb Avenue, Tampa, Florida 33629.

ARTICLE III. – DURATION. The Company's existence commenced upon the filing of these Articles with the Florida Department of State, and the Company will exist perpetually, unless terminated in accordance with law.
