

ARTICLES OF ORGANIZATION OF CORPORATE GIFTS & SPECIALTY BASKETS, L.L.C.

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge and file the following Articles of Organization.

ARTICLE I – NAME

The name of the limited liability company shall be Corporate Gifts & Specialty Baskets, L.L.C. (the "Company").

ARTICLE II – ADDRESS
