ARTICLE I - NAME

The name of the limited liability company is DPF CONSTRUCTION, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS

ARTICLE III - PURPOSES AND POWERS

ARTICLE VI - MANAGEMENT


