**ARTICLES OF ORGANIZATION  
OF NCVH, LLC**

The undersigned, acting as the Authorized Representative of this limited liability company pursuant to Chapter 608 of the Florida Statutes, hereby forms a limited liability company under the laws of the State of Florida and adopts the following Articles of Organization for said limited liability company:

**ARTICLE I - NAME OF LIMITED LIABILITY COMPANY**

**ARTICLE II - PERIOD OF DURATION**

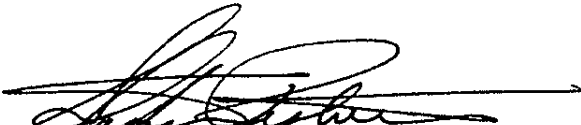
