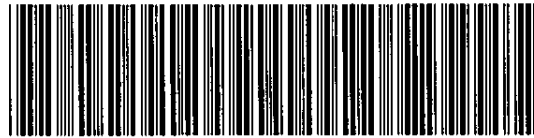


SECOND: The Articles of Organization of the Company were filed with the Florida Department of State on October 17, 2012, and the document number of the Company is L12000132731.
