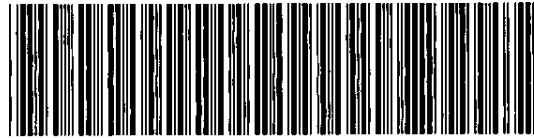

BRAD HAHN & ASSOCIATES, LLC is to be managed by its Member and the name and address of the individual who will serve as the managing member is:


