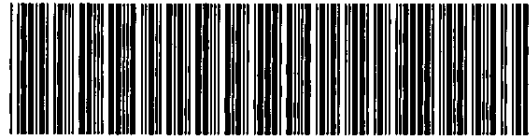





ARTICLE VI – Limitation on Agency Authority of Members


