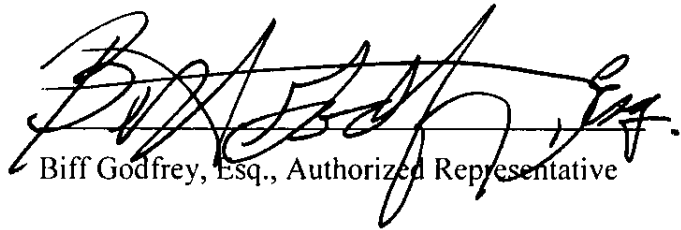
#### **ARTICLE VI**
