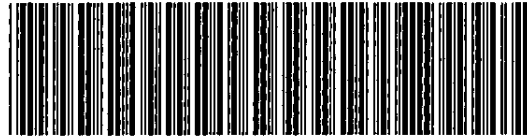

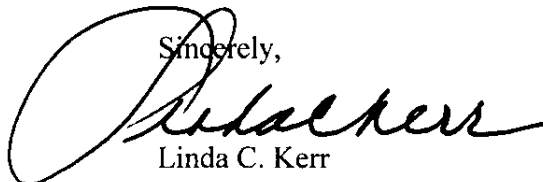
Ladies and Gentlemen:

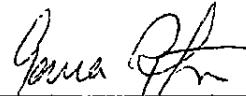
Ladies/Gentlemen:

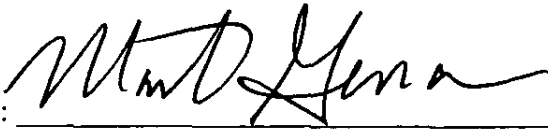
