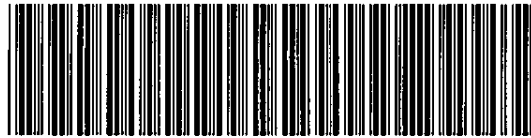


ARTICLE IV - MANAGER
