ARTICLES OF ORGANIZATION

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE 1 - NAME

The name of the limited liability company shall be GREEN MILE, LLC ("Company").

ARTICLE 2 - ADDRESS

ARTICLE 6 - REGISTERED OFFICE AND REGISTERED AGENT

ARTICLE 7 - ADMISSION OF NEW MEMBERS

ARTICLE 10 - UNITS

The company shall be authorized to have three (3) classes of units of equity interest in the company: Class A unlimited voting manager class consisting of 100,000 units. Class B limited non-voting non-manager class consisting of 100,000 units. Class C limited non-voting non-manager class consisting of 100,000 units.
