Pursuant to the provisions of Florida Statutes §608.411(3), the above-named Florida limited liability company hereby adopts the following Amended and Restated Articles of Organization, which amends and restates the Articles of Organization originally filed on October 23, 2012.

The undersigned for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby make, acknowledge, and file the following Articles of Organization pursuant to Florida Statutes §608.411(3).

### ARTICLE I NAME

Except as set forth in the operating agreement, no additional members shall be admitted to the Company except with the unanimous written consent of all the members of the Company and on the terms and conditions as shall be determined by all the members.
