**ARTICLES OF ORGANIZATION**

of

**ABEYON, LLC**

(A Florida Limited Liability Company)

The undersigned, desiring to form a Limited Liability Company in the State of Florida pursuant to Chapter 608, F.S., hereby certifies:

**ARTICLE I - NAME**

The name of the limited liability company shall be Abeyon, LLC, hereinafter referred to as the "Company."

**ARTICLE II - ADDRESS**

The principal street address and mailing address of the Company is 9371 SW 78<sup>th</sup> Court, Miami, FL 33156.

**ARTICLE III - PURPOSE**

The Company is organized to conduct business for any and all lawful purposes under the laws of the State of Florida.

**ARTICLE IV - MANAGEMENT**

The Company shall be managed by one or more members, and therefore will be a member-managed company. The initial manager of the Company shall be Geeta Nayyar. The Operating Agreement may contain additional information or provisions concerning the management and regulation of the Company and its affairs, but shall not be inconsistent with the laws of the State of Florida or these Articles.

**ARTICLE V - REGISTERED AGENT**

The Registered Agent of the Company shall be Geeta Nayyar. The address of the Registered Office is 9371 SW 78<sup>th</sup> Court, Miami, FL 33156. The Registered Agent accepts this designation and agrees to comply with the provisions of Chapter 608 F.S. regarding the same.

**ARTICLE VI - DURATION**

The Company's duration shall commence upon the filing of these Articles with the Florida Department of State and shall continue in perpetual existence, unless earlier dissolved: (i) in accordance with the Company's Operating Agreement, or (ii) upon unanimous written consent of all the membership interests.


**ARTICLE VII - AMENDMENT**
