AMENDED ARTICLES OF ORGANIZATION

In accordance with the provisions of Section 605.0202 of the Florida Revised Limited Liability Company Act, ABEYON LLC hereby adopts the following amendment to its Articles of Organization, which were filed on October 23, 2012.
