**FOURTH AMENDED
ARTICLES OF ORGANIZATION**

of

**ABEYON LLC
(A Florida Limited Liability Company)**

In accordance with the provisions of Section 605.0202 of the Florida Revised Limited Liability Company Act, ABEYON LLC hereby adopts the following amendment to its Articles of Organization, which were filed on October 23, 2012 and assigned document number L12000135092. The Articles of Amendment were duly adopted on July 1, 2019, by the required percentage of the Membership entitled to vote on the amendment.

ARTICLE I - NAME

The name of the limited liability company shall be ABEYON LLC, hereinafter referred to as the "Company".

ARTICLE II - ADDRESS

The principal street address and mailing address of the Company is hereby amended, and shall be 95 Merrick Way, Suite 313, Coral Gables FL 33134.

ARTICLE III - PURPOSE

The Company is organized to conduct business for any and all lawful purposes under the laws of the State of Florida.

ARTICLE IV – MANAGEMENT

The Company shall be managed by one or more managers and is a manager-managed Company. The initial managers of the Company shall be Malleesh Murugesan and Xianfeng Yuan. The Operating Agreement may contain additional information or provisions concerning the management and regulation of the Company and its affairs, but shall not be inconsistent with the laws of the State of Florida or these Articles.

Members of the Company may be added or removed, from time to time, as provided by law or in the Company's Operating Agreement.

The Company's duration shall commence upon the filing of these Articles with the Florida Department of State and shall continue in perpetual existence, unless earlier dissolved by operation of law or: (i) in accordance with the Company's Operating Agreement, or (ii) upon unanimous written consent of all the membership interests entitled to vote on such matters.

ARTICLE VIII – AMENDMENT

These Articles may be amended only as provided by law or in accordance with the Company's Operating Agreement.


