ARTICLES OF ORGANIZATION

OF

THE GREAT DIVIDE, LLC

The undersigned, pursuant to the provisions of Chapter 08 of the Florida Statutes (the "Florida Limited Liability Company Act"), for the purpose of forming a Limited Liability Company under the laws of the State of Florida do set forth the following:

1. NAME.

The name of the Limited Liability Company is The Great Divide, LLC (hereinafter referred to as the "Company").

PERIOD OF DURATION.

The period of duration of the Company shall not exceed the maximum term permitted under the Florida Limited Liability Company Act. 3. PURPOSE.

6. INITIAL CAPITAL CONTRIBUTIONS.


The total amount of cash and a description of the agreed value of property other than cash contributed to the Company is as follows: One Hundred and No/100 Dollars (\$100.00) in cash.

The Company shall be managed by its Members.

10. INDEMNIFICATION.

Unless expressly agreed otherwise in writing by all of the Members, the Company shall indemnify any Member or former Member which provides management of the Company to the full extent permitted under the Florida Limited Liability Company Act.

11. EFFECTIVE TIME.

These Articles shall be effective when filed with the Florida Department of State.
