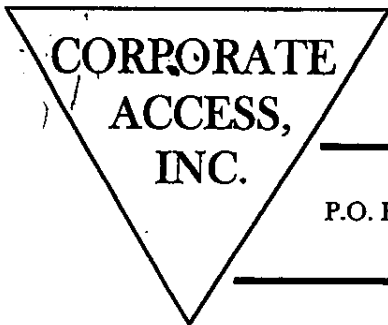

The mailing address and the street address of the principal office of the Company is 1050 Talleyrand Avenue, Jacksonville, Florida 32206.


**ARTICLE IV
