**ARTICLES OF ORGANIZATION
OF
CONTERNO INFORMATION SYSTEMS LLC**

Conterno Information Systems LLC, a Florida limited liability company, pursuant to Section 608.407 of the Florida Statutes, does hereby adopt the following Articles of Organization for Conterno Information Systems LLC (the "Company"):

ARTICLE I - NAME

ARTICLE VI - LIMITATION OF LIABILITY

To the fullest extent permitted by Florida law, no managing member of the Company shall be liable to the Company or the other members for monetary damages for an act or omission in such managing member's capacity as a manager of the Company, except to the extent provided in Section 608.4228 of the Florida Statutes (or any successor provision thereto). Any repeal or amendment of this Article by the members of the Company shall be prospective only and shall not adversely affect any limitation on the liability of a managing member of the Company existing at the time of such repeal or amendment. The foregoing elimination of the liability to the Company or the members for monetary damages shall not be deemed exclusive of any other rights or limitations of liability or indemnity to which a managing member may be entitled under Section 608.4228 or Section 608.4229 of Florida Statutes or under any other provision of this Articles of Organization and any other written contract or agreement, any vote of members and/or disinterested members of the Company, or otherwise.

ARTICLE VII - INDEMNIFICATION

The Company shall indemnify persons for whom indemnification is permitted by Section 608.4229 of the Florida Statutes to the fullest extent permissible under that Section and may purchase such indemnification insurance as the managing members from time to time shall determine.

ARTICLE VIII - ACTION WITHOUT MEETING

Any action required by the Florida Statutes to be taken at any annual or special meeting of members of the Company, may be taken without a meeting, without prior notice, and without a vote, if a consent or consents in writing, setting forth the action so taken, shall be signed by the holder or holders of membership interest having not less than the minimum number of votes that would be necessary to take such action at a meeting at which the holders of all membership interest entitled to vote on the action were present and voted. Any such written consent must be dated, signed and delivered in the manner required by, and shall be effective for the period specified by the Florida Statutes and the taking of any such action by written consent shall be subject to satisfaction of all

applicable requirements of the Florida Statutes. Prompt written notice of the taking of any action by members without a meeting by less than unanimous written consent shall be given to those members who did not consent in writing to such action.
