**ARTICLES OF ORGANIZATION

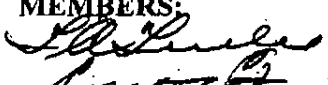
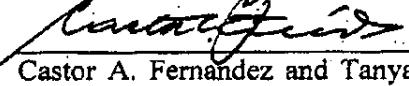

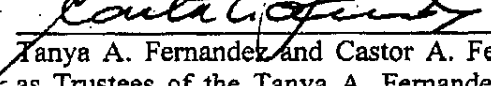
AMENDMENT
