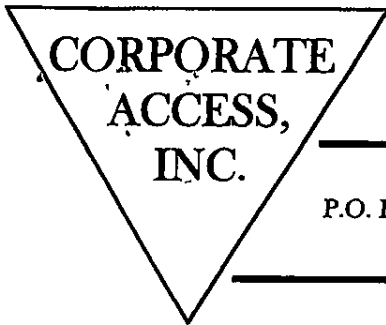

ARTICLES OF ORGANIZATION

The undersigned, being the Initial Member and Organizer of the Limited Liability Company hereby being formed under Florida Statutes, §§ 608.401 to 608.471, does hereby adopt the following Articles of Organization for the Limited Liability Company:

FIRST, the name of the Limited Liability Company is: **KP ISLAND ENTERPRISES, L.L.C.**

SECOND, the latest date on which the Limited Liability Company is to dissolve is October 17, 2062.

THIRD, The Limited Liability Company is organized to engage in and do any lawful act concerning any lawful business, other than banking and insurance, for which a limited liability company may be organized in accordance with Florida Statutes, §§ 608.401 to 608.471, including all powers and purposes now and hereafter permitted by law to a limited liability company.

FOURTH, the street address of the initial registered office of the Limited Liability Company in Florida is: 151 Genoa Street, Indian Harbour Beach, Florida 32937 and the name of the initial registered agent of the Limited Liability Company in Florida at the address is **KENNETH JOSEPH PUCEL**.

FIFTH, the mailing address and principal office of the Limited Liability Company is 151 Genoa Street, Indian Harbour Beach, Florida 32937.

SIXTH, the Limited Liability Company is to be managed by a Manager. The name and address of the initial Manager is: **KENNETH JOSEPH PUCEL**, having an address at 151 Genoa Street, Indian Harbour Beach, Florida 32937.

SEVENTH, the total amount of cash (and a description and agreed value of any property other than cash) contributed to the Limited Liability Company, as capital, by the Member is \$5,000.00. The Initial Member's initial capital contribution was contributed at the following valuation, as agreed upon by the Member:

The allocations and distributions of the Limited Liability Company shall be made in proportion to the Member's Percentage Interests.

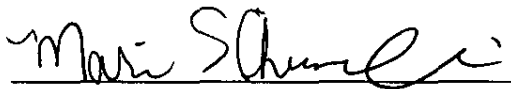

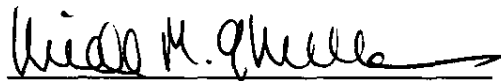

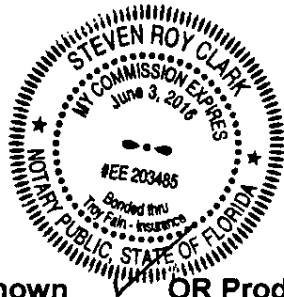
