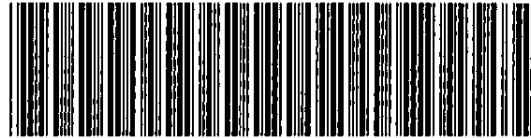

7. **Management.** Management of the limited liability company at the time of formation shall be by the managing member whose name and address is as follows:




