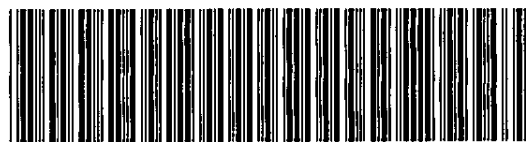


ARTICLE IV - REGISTERED OFFICE AND AGENT

ARTICLE V - MANAGEMENT




