**ARTICLES OF ORGANIZATION
OF
HG COLUMBIA DEVELOPERS PHASE II, LLC**

1. NAME. The name of this limited liability company is HG Columbia Developers Phase II, LLC (the "Company"), and it shall be formed as a limited liability company under Chapter 608 of the laws of the State of Florida.



5. OPERATING AGREEMENT. The manager or managers shall have the power to adopt, alter, amend, or repeal the Operating Agreement of the Company containing provisions for the regulation and management of the affairs of the Company.


