ARTICLES OF ORGANIZATION*of***PROVIDENCE SQUARE, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes, Chapter 608, hereby makes, acknowledges and files the following Articles of Organization.

ARTICLE I**NAME AND ADDRESS**

The name of the limited liability company shall be Providence Square, LLC (the "Company"). The mailing address and street address of the principal office of the Company in Florida shall be 12819 Bay Plantation Drive, Jacksonville, Florida 32223.

ARTICLE II**PURPOSES AND POWERS**

The general purpose for which this Company is organized is to transact any lawful business for which a limited liability company may be organized under the laws of the State of Florida. ARTICLE VI**MANAGER**



