

ARTICLES OF ORGANIZATION OF
AJD II LLC

The undersigned, desiring to form a Limited Liability Company under and pursuant to §608.405, Florida Statutes, does hereby certify as follows:

- FIRST: The name of said limited liability company shall be AJD II LLC.
- SECOND: AJD II LLC shall exist in perpetuity.
- THIRD: Copies of the Operating Agreement of AJD II LLC may be obtained from the Manager at 7994 Royal Birkdale Circle, Bradenton, Florida 34202 which is the place in the State of Florida where the principal office of the limited liability company is located. The mailing address of AJD II LLC shall be 7994 Royal Birkdale Circle, Bradenton, Florida 34202.
- FOURTH: The purposes for which AJD II LLC is formed are:
- A. To acquire investment and personal use assets;





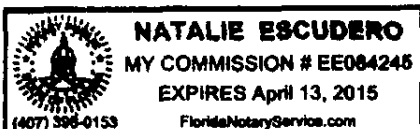
