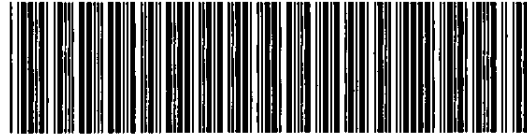

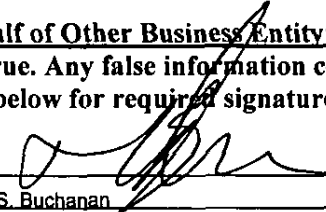

5. The undersigned Shareholder and Member hereby authorizes the execution and filing any and all documents required by the Florida Department of State to effectuate this conversion.

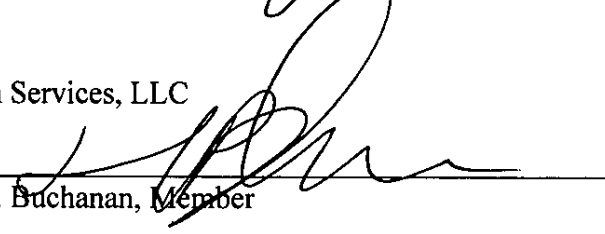
